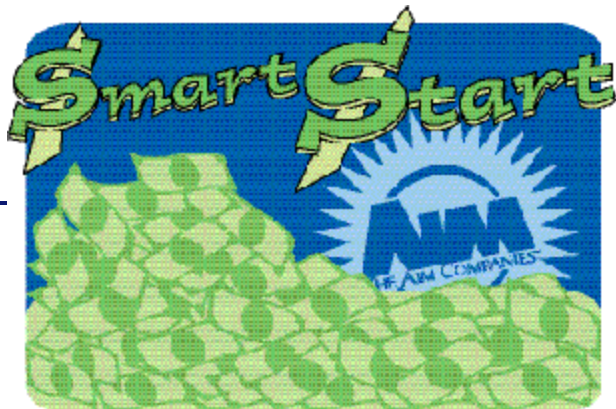


* In order to receive commissions, you must qualify at the highest title you achieve during the month. **Note:** Until you promote to Director, you are required to be one title above the person you have sponsored in order to earn commissions.

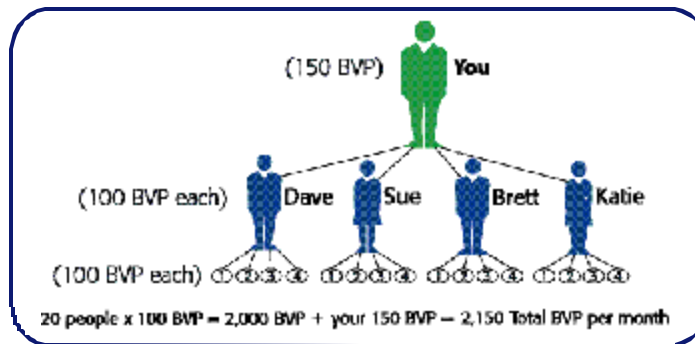
The more Members in your group, the greater your income

Like compounding interest, the more people you share AIM with, and the more people they share AIM with, the more your income grows. Here's just one example to show you how easy it is to be successful.

How to move up from a Member to a Director.

Here is a simple illustration of how you might quickly move up from being a Member to a Director. (Express Customers cannot sponsor others.)

- You order 150 Personal Volume (PV) each month
- You find just four other people with whom to share AIM BarleyLife® and sponsor them
- The four people you sponsored each sponsor four people
- Each of them order 100 BVP for three months
- Voila! You're a Director!



In a three-month window, you accumulate 6,450 Group Volume Points (GVP) – enough to reach the Director level. (Once you reach the Director level you qualify with 150 PV.)

How much income you would receive.

In the above example, you receive 18% of 150 BVP (a Director has to qualify with 150 PV)—so you just earned \$27. You also get 12% of the remaining 2,000 Group Volume (GV), which amounts to \$240 for a total of \$267. The four Preferred Members below you receive 6% of 500 GV which is \$30 each.

If each person in your group sponsors just one more, you can reach the Director level in just two months.

Sponsoring just one more person makes a big difference.

Other ways to increase your income

Leadership Bonus Program:

Rewards for your hard work.

Strong leadership is the foundation of any business, and we believe your leadership efforts should be rewarded. All phases of AIM's Leadership Bonus Program dramatically increase your earning potential.

Director Growth Bonus Pool

As a Director, your organization increases in depth and stability as each of your Members begins to actively participate in AIM's Opportunity Compensation Plan. The Director Growth Bonus recognizes your organization's growth. All you need to do to receive this bonus is make personal purchases that total 300 BVP and motivate your growing organization to accumulate at least 1,500 GV (includes PV) in one business month.

This Director Growth Bonus Pool rewards those who have grown their organization to where they have achieved Director status. You'll be rewarded with shares in a pool of 4 percent of AIM's global BVP. (Paid monthly.)

Director Three-deep Bonus Pool

The most powerful concept in training your group is to teach simple business-building formulas to Members three levels deep in your organization. By teaching your team to always work three levels deep, you create a natural mentoring program and a team interested in each person's success. By using and teaching this concept, you will build tremendous strength in your business. To receive this bonus you must enter the month as a Director and make personal purchases that total 300 BVP and you must have a group volume of at least 1,500 GV (includes PV). The Three-Deep Bonus rewards this dynamic business principle.

You earn shares based on your Group Volume and on the Group Volumes of your First-, Second-, and/or Third-Generation Directors with 300 PV and 1,500+ GV. Directors receiving this bonus must have a Group Volume greater than that of the Director on which they are receiving the Three-Deep Bonus. Otherwise, the receiving Director will earn shares based on their own Group Volume.

This Director Three-Deep Bonus Pool rewards those who teach their team to work three levels deep—creating a natural mentoring program that builds business. You'll be rewarded with shares in a pool of 2 percent of AIM's global BVP. (Paid monthly.)

Elite Leadership Bonuses

While Director Bonuses reward you for developing a broad organization, the Elite Leadership Bonuses reward you for developing a deep organization.

To qualify, you must enter the month with the Elite title of Star Sapphire Director or above and have personal purchases that total 300 BVP. Your downline must have 3,000 GV and have two to six legs (see *Glossary of Terms*, p. 15) with 20,000 Total Downline Volume (TDV) per leg.

Note: You will be paid at the highest Elite Leadership Bonus achieved during the month.

These Elite Leadership Bonuses reward you for developing a deeper, more active organization. You'll be rewarded with a 1 percent to 3 percent bonus on the Group Volume (GV) of your 4th to 6th Generation Directors or on the Group Volumes of the generations on which you are entitled to receive bonuses, based on the title at which you enter the month. (Paid monthly.)

For example, a Royal Emerald Director qualifying for the Four-Star Bonus will receive an additional 2 percent bonus on the Group Volumes of his/her Fourth- and Fifth-Generation Directors. In comparison, a Blue Diamond Director qualifying for the same bonus would receive an additional 2 percent bonus on his/her Fourth-, Fifth-, and Sixth-Generation Directors.

Your formula for success.

Every successful AIM business-builder has built into his or her business five simple elements that are vital to success. We call them USSBT:

- U**se the AIM Products. Learn how, when, and why to use the products, and where to store them.
- S**hare the AIM Products through personal contacts, tradeshows, advertising, and public speaking.
- S**ponsor others to build your network.
- B**uild strong relationships by meeting your Members' and customers' needs.
- T**each others to do the same.

Members and above can sign up for AIM's Insta-Order™ program. This gives you the convenience of receiving your favorite AIM products each month on a reoccurring basis, plus you'll save a minimum of 10 percent on every order, regardless of its dollar value. Plus all AIM Insta-Orders receive FREE shipping.

With AIM's Insta-Order™ program, you'll have more time to concentrate on what you really care about, such as spending time with family and friends or expanding your AIM business.



FAQs

Q. How do I accumulate points?

A. By you or your downline ordering AIM products. Each AIM product has a designated BVP assigned to it.

Q. What are the points used for?

A. Earn enough points and you will be promoted to a higher title, which in turn will allow you to earn a larger commission and can also entitle you to a free annual renewal.

Q. How do you define a “consecutive three-month period?”

A. A three-month period constitutes the current month you’re in, plus all of the next two months. For example, you need 450 GV between you and your downline to advance from a Member to a Preferred Member. If you sign up in July with a 50 BVP order, you have through the end of September to earn that 450 GV. If you don’t earn enough points by the end of September you lose just the points accumulated in July, and then have through the end of October to once again try to achieve the 450 GV. If you still don’t make it, you lose just your August points and the accumulation of points begins again from September through the end of November.

Q. Do I need to place a qualifying order each month to retain my title and commission percentage?

A. No. Once you achieve a title it is permanently yours as long as the membership is kept active.

Q. Do I earn commissions if I don’t order?

A. No. If you don’t place a qualifying order for the title you hold in the same month that your downline places an order, you are not paid commission on your downline GV. If you place an order for less than your qualifying order, you earn commission only on your own order.

Q. Why am I not being paid on my downline?

A. One possibility is that you are at the same title as your downline, for example you’re a PCL and are sponsoring one or more PCLs. If this is the case, you will get paid commission again once you promote ahead of them. Another possibility is that you didn’t place your qualifying order for the month.

Q. Since I earn commissions, do I have to provide my Social Security number? (U.S. only.)

A. It is an IRS requirement that AIM report income attributable to your Social Security number. If we are unable to provide this information, AIM must automatically deduct 28 percent tax from your commission to stay in compliance with IRS regulations.

Glossary of Terms

Bonus Volume Points (BVP):

Point value assigned to products. BVP is used to determine promotions, qualifications, and commissions. BVP is totaled monthly. See current company price list and order form for BVP on individual products.

Compensation Plan:

The commission and bonus schedule based on products purchased from the company.

Commissions:

The regular commissions a person earns after signing up as an AIM Member or Express Customer based on his/her compensation plan title and the BVP of purchases made by himself/herself and his/her network of Members. These are paid each month that a Member makes a qualifying purchase.

Compression:

Maximizes commission potential by ensuring that all possible qualifying levels are filled with productive downline Members. Levels or generations compress so that Members not qualified to receive regular commissions become invisible during calculation of commissions. They do not lose their position or title permanently.

Downline:

All Members and Express Customers who have joined AIM through you—whether you personally sponsored them or you are upline from their personal sponsor. Your downline Members and Express Customers are sometimes referred to as your organization, network, or group.

Elite Directors:

Directors who promote to the top four titles in the compensation plan—Star Sapphire, Royal Emerald, Blue Diamond, and Chairman's Club.

Express Customers (EC):

Express Customers enjoy many of the benefits of AIM Membership without having to meet the criteria of AIM Membership. Benefits for ECs include: No application fee. Purchase AIM products at Express Customer price. Volume discounts. Toll-free ordering and customer service. No contact from AIM unless requested.

Generations:

A Director's relationship to other Directors within his/her organization. Personally sponsored Members who promote to Director (including Elite Directors) become First-Generation Directors to the sponsoring Member. A Director sponsored by a First-Generation

Director becomes a Second-Generation Director to the original sponsor, etc. Generations are distinguished from levels for the purpose of calculating commissions accurately; when Members in your downline promote to Director, their Group Volume is recorded separately from your personal Group Volume.

Group Volume (GV):

For regular commissions, the sum of a Member's Personal Volume and the volumes (including downline volume) of all personally sponsored Express Customers, Wholesale Members, Preferred Members, Product Consultants, Group Builders, and Associate Directors.

Leadership Bonus:

Extra compensation for meeting specific bonus requirements.

Legs:

All Members in a First-Generation Director's organization to unlimited generations.

Levels:

A Member's relationship to his/her upline and downline. Levels refer to how many memberships there are between you and another Member in your network. Someone personally sponsored by a Member is referred to as first-level. A Member sponsored by the first-level Member is second-level to the original sponsor.

Monthly Qualifying Order:

The minimum monthly personal purchase required to qualify for regular monthly commission checks.

Personal Volume (PV):

The BVP value of any purchase made under a Member's own identification number.

Sponsoring:

Personally signing up people to become Members or Express Customers.

Total Downline Volume (TDV):

All the volume earned in one leg throughout every generation.
