**Definitions:**

- Level 1:** MLM approved; Retail Approved (Flag on website, regional language, order forms, local currency)
- Level 2:** MLM approved; Retailers responsible for own importing and licensing. Still require normal Retail assignment procedure ie: a Rep Sponsoring in that Country. To use Other Countries order forms and purchases in US Dollars. (Canada is the exception as country specific forms are currently in use.)
- Level 3:** MLM approved; No Retail Allowed (Due to restrictions or planned Level 1 status),  
\* Level 3 includes UK, Japan, Europe, France, Mexico, Brazil, Malaysia, South Korea, India (3 states only – please see below)
- Level 4:** No MLM, No Retailing, No strategies at all.

**Notes:-**

- ① Products in Expo's and Markets are permitted for display purposes only and not for retail sales. Customers may be signed up to purchase on line from the company.
- ② All channels of distribution in all countries are subject to each country's laws (eg: MLM is restricted in some countries or requires a licence such as China, Malaysia and South Korea.)
- ③ India is unavailable in all states except for the following: which are Level 3 – Maharashtra (Bombay-Mumbai), Karnatika (Bangalore), Tamil Nadu (Madras- Chennai)

**Policy Guide for Retailers:**

All Retailers must go through Store Assignment procedure, facilitated by Managers and above. Testers, Wobblers and Free Brochure policies apply to Level 1 Retailers only. 50% Discount available to approved Retailers only at Level 1 or 2 for orders over \$7500 retail. Level 2 Retailers at 50% discount levels must allow 10-20 day packing and dispatch time, and may be charged a shipping fee for air freight.

**Exclusivity**

MiVitality Products (such as In-Liven) are exclusive to MLM sales in Level 2 and 3 countries.
